



## **Enrollment/Tuition Contract**

### **Roots & Vines Foundational Herbology Program**

Thank you for signing up for the Roots & Vines Foundational Herbology Program. We are so glad to have you join us this year! This letter sets forth the terms and conditions of agreement between you and Sacred Garden School, LLC ("SGS") for your enrollment in this program. While I believe this letter is straightforward, please read it closely and if you have any questions, please contact me.

**1. Program Enrollment.** Foundational Herbology meets the third weekend of each month (excepting April), March through November. We meet from 10:00 am- 5:00 pm on Saturdays, and 9:00 am - 4:00 pm on Sundays, beginning March 21, 2026. Our last class will be on November 22, 2026. You agree to make reasonable efforts to attend classes and to contact SGS when you cannot attend. While you are responsible for keeping up with assignments and class attendance, SGS reserves the sole right not to award any class certificate based on excessive class absenteeism, failure to keep up with program work, disruptive behavior in class (and/or to any fellow students) and any other reason where SGS, in its sole reasonable judgment, determines that you did not exemplify the knowledge, skills and/or conduct to certify that you possess such qualities in relation to your program course work. You acknowledge that the program is solely for personal educational knowledge and SGS makes no promises or guarantees to you concerning any matter related to the program that is not expressly stated in this letter agreement.

**2. Costs and Expenses.** A deposit of \$275 is required to hold your place in this program. *The deposit is non-refundable and non-transferrable.* The deposit is deducted from the tuition and remaining balance after the deposit is can be paid in full for a discount (see below) or split into monthly payments.

#### **Tuition Costs**

The total tuition for the program \$2875, but a number of discounts are available:

- A \$175 early-bird discount is applied to people who register by February 1, 2026. To receive this discount, you must pay the \$250 deposit no later than midnight on the 1<sup>st</sup> of February.
- A \$175 discount is offered to those who pay the remaining balance in full by March 21, 2026 (our first day of class).
- A \$200 discount is available to anyone who registers with a friend (Make sure that the friend lets me know who referred them at the time of registration)

#### **For Students paying Full Tuition before Program Begins**

If you intend to pay in full by March 1, 2026 for a \$175 discount, please let me know and I will have an invoice ready for you with the final balance including any additional discounts on the first weekend of class. The remaining balance can be paid with cash, check or money order, and either brought with you to class or mailed to:

If you prefer to use credit card, I can send you an invoice through Square (please note that a 3% fee will be added for payments made through Square)

Subsequent to SGS's receipt of your program payment in full, should you decide to withdraw from the program, you will be entitled to a refund as follows:

- a. If you withdraw up until 1 weeks from the first day of class, you will receive 80% of the tuition;
- b. If you withdraw within 4 weeks after our first day of class, you will receive 75% of the tuition; or
- c. If you withdraw after April 19<sup>th</sup>, you will not be entitled to any tuition refund, however, you will retain credit that can be applied towards future classes.

Tuition refunds, if any, shall be sent to you no later than 14 days after the date of your withdrawal in writing to SGS. If, for any reason, your check is returned or is non-negotiable at your bank, you agree to pay a fee of \$50 in addition to all amounts owed to SGS.

#### **For Students requiring a Payment Plan**

A deposit of \$275 is required to hold your spot, due no later than March 14, 2026. The total tuition for the program, less your deposit and any applicable discounts, will be broken into 9 equal payments. SGS agrees to accept your enrollment with the following payment plan amounts and due dates:

9 equal installment payments on the following dates:

- 1) March 21, 2026, 2) April 18, 2026, 3) May 16, 2026, 4) June 20, 2026 5) July 18, 2026
- 6) August 15, 2026, 7) September 19, 2026, 8) October 17, 2026, 9) November 21, 2026

Should you decide to withdraw from the program, you will be entitled to a refund as follows:

- a. If you withdraw up until 1 week from the first day of class, you will be charged for 20% of the tuition;
- b. If you withdraw within 4 weeks after our first day of class, you will be charged for 25% of the tuition; or
- c. If you withdraw after April 19<sup>th</sup>, 2026, you will be responsible for the full balance plus any fees incurred to SGS related to collection of the balance.

**3. Binding Agreement.** If you fail to meet any of your obligations under this Agreement, including the payment of any fees or costs, SGS shall have the right to terminate this Agreement upon 7 seven days prior written notice to you sent to the address above. Further, you agree to indemnify and hold SGS harmless from all costs and expenses (including reasonable attorneys fees) incurred by SGS in any collection matter or any other action initiated by SGS related to your breach of this letter Agreement. This letter agreement represents the complete agreement and understanding between you and SGS regarding the program and is governed solely by the laws of the state of West Virginia. The venue of any legal action related to this letter agreement shall solely occur in the federal or stated courts located in the City of Charles Town, West Virginia.

All students are responsible for paying tuition in full by the end of the course, November 22, 2026. Failure to complete payment will result in your certificate of completion being withheld.
